Summary: Provides that the lieutenant

governor will act as the governor if there is a temporary disability of the governor.

Further provides that the lieutenant governor or lieutenant governor-elect

will be the governor or governor-elect in the case of the resignation, death, or

permanent disability of the governor or governor-elect thus creating a vacancy

in the office of lieutenant governor or lieutenant governor-elect, as

appropriate.
